Notes:

- (1) Annual fees are payable by all persons registered for as long as they are registered with ECSA, annual fees are raised every year for the period 01 April to 31 March.
- (2) Payment details:
 - a. Persons in foreign countries who are experiencing difficulties making payment by credit card are advised to use the Online Portal to make payment or Netcash.
 - b. Credit card payments can be made by scanning the secure Netcash QR code or by clicking on the Netcash icon appearing on your invoice.
 - c. ECSA is now a public recipient and banks with both FNB and Standard bank.
 - d. The accepted methods of payment are EFT and Netcash links as indicated above.
 - e. For all payments, please use the reference number at the bottom of your invoice.
- (3) No Applications will be considered until payment for the full application fee has been received.
- (4) Professional application fee will be split into vetting and application fee.
- (5) Persons registered in the Candidate category for more than six (6) years pay the same annual fees as persons registered in the Professional category.
- (6) If a person wishes to appeal an outcome received, a fee of **R8 988** is to be paid before lodging an appeal.
- (7) An Early bird discount is granted to Registered persons if their annual fees for April to March are paid on or before 30 June. **The discount is R100 for Candidates and R250 for Professionals, VAT inclusive.**
- (8) In addition to the annual fees in arrears, an admin fee of **R500** is payable when reinstating a registration after a cancellation.
- (9) Persons who reside outside the RSA borders for a year or longer should advise ECSA of their overseas postal address to ensure VAT is not charged.
- (10) The fee for persons between the ages of 55 and 70 who have been granted the retired dispensation will be **R429** (VAT inclusive).
