About ECSA



Interested parties must submit their proposals in **hard copy** (one printed copy) **and** electronically on a **memory stick**. The financial proposal must be sealed in a separate envelope within the pack and be stored on the memory stick as a separate file, clearly named. The pack must include the name and address of the bidding party, the proposal reference number, and the closing date clearly marked on the outside of the pack.

The submission must be placed in the ECSA Tender Box located in the Reception of ECSA, 1st Floor Waterview Corner, 2 Ernest Oppenheimer Avenue, Bruma, Johannesburg to arrive no later than closing date and time indicated above.
